

Impact of Inflation on College Costs

What Is the Impact of Inflation on College Costs?

Unfortunately, college costs have historically been rising at a faster rate than the general inflation rate. Covid-19, however, has had an impact on the cost of higher education, resulting in the lowest increases since 1990-91.

For the 12 months from October 2020 to October 2021, the inflation rate was 6.2% (source: Consumer Price Index; CPI-U; Percent Change October 2020 to October 2021). For a similar period of time, tuition and fees at four-year colleges increased an average of 1.6% at public colleges and 2.1% at private nonprofit colleges? (source: The College Board Trends in College Pricing 2021).

Failing to consider the impact of inflation on college costs could undermine your ability to provide for your child's education, despite the current impact of the covid-19 pandemic.
